Authentic Web maintains new TLD registry overviews available to clients. Below is a sample registry overview for the .BANK TLD. .BANK is one of the most restricted Top Level Domains that is not a Brand Registry. This overview is provided for information purposes and subject to change based on updated Registry Operator actions.

Description	.BANK is a TLD for the global banking community with a goal of becoming the trusted source for information about the banking industry. .BANK is run by fTLD and was founded by the Financial Services Roundtable and the American Bankers Association (ABA) along with several founding members from the banking community, including the Canadian Bankers Association (CBA). fTLD also runs .INSURANCE. .BANK is unique from most new TLDs due to its stringent registration restrictions limited to the banking community. fTLD seeks to enhanced security standards for .BANK created by the financial services industry, content use requirements and rigid enforcement for .BANK domain holders will contribute to security, stability and increased consumer trust for registrants.
Registry Policies	Registration Restrictions Only verified members of the banking community are permitted to own a .BANK. Qualifications include: 1. Chartered state, regional and provincial banks, supervised by a government regulatory authority. 2. Savings associations that are chartered and supervised by a government regulatory authority. 3. National banks that are chartered and supervised by a government regulatory authority. 4. Associations whose members are primarily comprised of entities identified above in 1, 2 or 3. 5. Groups of associations whose members are primarily comprised of associations identified above. 6. Service providers that are principally owned by or predominantly supporting regulated entities identified above in 1, 2 or 3 (if approved by the FRS Board); and 7. Government regulators of chartered and supervised banks or savings associations or organizations whose members are primarily comprised of such government regulators (if approved by the FRS Board). Enhanced Security .BANK states they will include security and other protocols to help protect against fraud. A strict vetting process for .BANK domains intends to reduce the frequency of phishing attacksBANK's security protocols include: 1. Mandatory Verification of Charter/Licensure for Regulated Entities 2. Mandatory Re-verification of Registration Data 3. Domain Name System Security Extensions (DNSSEC) 4. Email Authentication 5. Multi-Factor Authentication
